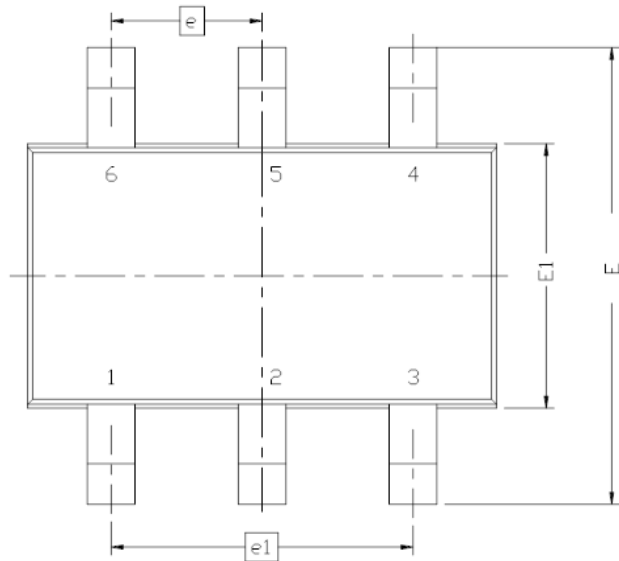
Typical Electrical Characteristics



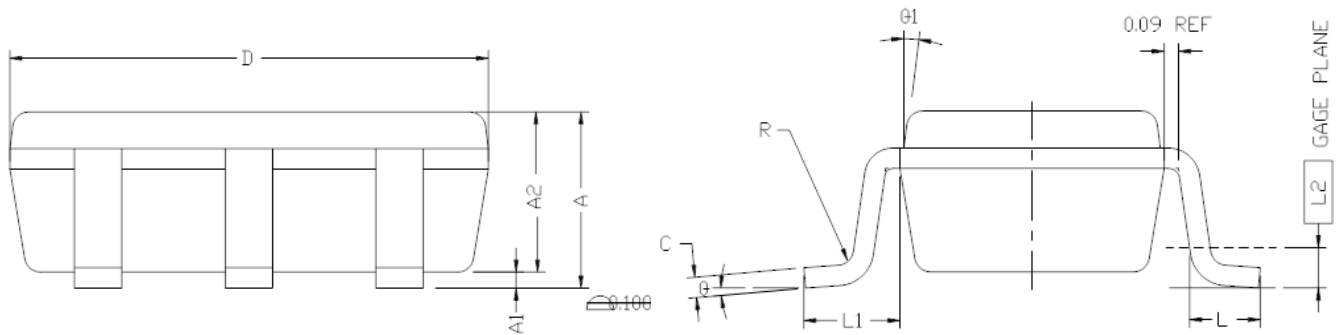
