It has been optimized for low gate charge, low $R_{\text{DS}(\text{ON})}$ and fast switching speed. extremely low $R_{\text{DS}(\text{ON})}$ in a small package.






Figure 1. On-Region Characteristics.




Figure 2. On-Resistance Variation with Drain Current and Gate Voltage.




Figure 3. On-Resistance Variation withTemperature.




Figure 4. On-Resistance Variation with Gate-to-Source Voltage.




Figure 5. Transfer Characteristics.





Figure 6. Body Diode Forward Voltage Variation with Source Current and Temperature.





Figure 7. Gate Charge Characteristics.








Figure 9. Maximum Safe Operating Area.

Figure 10. Single Pulse Maximum Power Dissipation.




Figure 11. Transient Thermal Response Curve.
